Global organization of local governments

The Global Forum for Social and Solidarity Economy (GSEF) was founded in Seoul (South Korea) in 2013, and is **an international organisation of local governments and civil society networks operating on a local, national or world scale**. All its members are committed to promoting the principles and values of the Social and Solidarity Economy as a means to achieve local development which is respectful of humans and the environment.

GSEF members, present in 37 countries, represent SSE in its various forms, i.e., the social companies, cooperatives, foundations, mutual organisations, local authorities or solidarity groups which put people before profit and advocate a collective, viable and innovative economy.

Since its creation, GSEF has worked to build and drive a global movement to unlock the potential of SSE in forging sustainable local growth across the five continents. While 2022 and 2023 were pivotal years for the recognition of GSEF on an international, national and local scale, it must pursue its efforts to inform populations and promote the practical implementation of Social and Solidarity Economy policies.

SSE defined

According to the UN Inter-Agency Task Force on Social and Solidarity Economy (UNTFSSSE), the Social and Solidarity Economy refers to the production of goods and services by a wide range of organisations and businesses with explicit economic, social and often environmental objectives, and who are guided by the principles and practices of cooperation, solidarity, ethics and democratic self-governance.



Vision

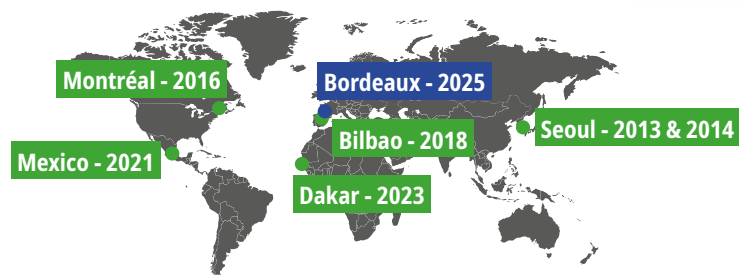
- GSEF **strives for a fairer world** with decent working and living conditions. It **aims to reduce inequalities and meet fundamental needs**.
- It is based on the **belief that systemic changes begin on a local level**, drawing on a partnership between civil society and the private or public sectors. The ultimate aim is that the SSE grows to become **the economic standard of the future**, incorporating collective management of shared assets.
- It is based on the **sharing of international experience and inspiring innovations** to address the major social and environmental challenges facing regions. It places the SSE at the service of communities and local government by providing resources and implementing SSE policies.
- It **cooperates with international networks**, while seeking a complementarity which is respectful of local diversity and identity. This action enables a coming-together of forces according to priorities, to promote SSE and the shift in development models it can bring about.
- It **shapes a core framework** for the implementation of the Sustainable Development Goals (SDG)



Joining our voices / Joining our forces

In 2021 GSEF teamed up with 4 other international SSE networks (AIM, ICA, ESSFI, ICMI) to boost its advocacy efforts in the framework of the International Coalition of Social and Solidarity Economy (ICSSE), and promote the role of SSE players on the international scene.

The Global Social and Solidarity Economy Forum



Every two years, a Global Social and Solidarity Economy Forum is co-organised with member cities worldwide. This forum has become a key event to take stock of the SSE's dynamism, and its political aspect is embodied by the Declaration issued after each edition. This gathering forms an ideal platform for mutual learning and the exchange of knowledge and visions around all aspects of the SSE.

Five areas of action



Advocacy on a local, national and international scale

GSEF defends the values and potential of the SSE on a global level, and has been working for many years with international, national and regional SSE networks, in addition to international entities such as the UN Inter-Agency Task Force on Social and Solidarity Economy (UNTFSSSE), the International Labour Organisation (ILO), the European Commission, the Organisation for Economic Cooperation and Development (OECD) and United Cities and Local Governments (UCLG), to promote the international recognition of the SSE.



Training and boosting regional abilities : from raising awareness to developing public policies

Thanks to its sound expertise in the SSE, GSEF offers numerous training possibilities to boost regional abilities, learning and policy dialogue.



Support for the development of public/private actors networks

GSEF provides SSE players from the public sector and civil society with a platform to exchange ideas, find potential partners and develop a solidarity support network. GSEF members can provide their expertise and experience to assist local players wishing to develop SSE networks on a regional level.



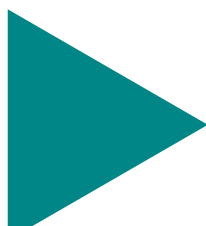
Applied research and publications

GSEF works alongside world-renowned researchers and institutes such as the UNRISD (United Nations Research Institute for Social Development) and the Karl Polanyi Institute of Political Economy. It contributes to the publication of reports and case studies proving the impact of SSE and demonstrating its potential in the creation of various international development programmes.



Promoting initiatives and experience sharing

GSEF creates in-person and virtual networking opportunities to connect members, facilitate exchanges between policy-makers and SSE players and strengthen the political framework of the SSE in various continents. In particular, it organises discussions on a continental scale, in addition to meetings between policy-makers and SSE players on a regional level.



Governance

The GSEF's purpose and stance are reflected in its governance with **the co-presidency of a local government (represented by the mayor of the chair city) and a representative of civil society networks.**

The decentralization of the network was asserted in 2021 with the creation of continental co-chairs whose role is to represent the GSEF and support its activities in their respective regions. The governance of the organization and **its fundamental principles are defined in the GSEF Charter.**

General Assembly

Steering Committee
