On behalf of the City of Bordeaux and the local governments co-chairing the GSEF, I would like to greet all member organizations of the network, its partners and long-standing allies, as well as the new members who joined us in 2024. Each year, the GSEF brings together new local governments and organizations, united around the values and principles of the Social and Solidarity Economy (SSE).

Now more than ever, it is our responsibility as local elected officials to strongly advocate for a new narrative of social cohesion and local solidarity—an economy that puts people at the center and respects natural resources and our environment. Today, our network can be proud of the progress it has made with all of you—whether in advancing continental dynamics or through the ongoing work of the thematic working groups. The GSEF provides a framework to share our visions and be inspired by the best practices implemented around the world. This is no easy task in a context marked by inward-looking policies and threats to democracy and multilateralism.

I would like to thank all those who contributed to the creation of the GSEF's intercontinental youth hub. Thanks to their commitment, young people from around the world are joining the movement for a sustainable, inclusive, and ecological future.

I am also pleased to see the development of new legislative frameworks, such as the one recently adopted in Côte d'Ivoire. I congratulate the GSEF members who played a part in this achievement. In 2024, Brazil also passed a framework law recognizing the role of SSE in combating poverty, hunger, and inequality. And the African Union adopted a ten-year SSE strategy. I could also mention the declaration by G20 labor and employment ministers in Fortaleza in July 2024.

In late November, the United Nations General Assembly adopted a second resolution on SSE: "Promoting the Social and Solidarity Economy for Sustainable Development." It includes the 7th edition of the GSEF Global SSE Forum on the international agenda for 2025.

Let us continue to develop innovative public policies to prove that another economy is possible—by and for the people and communities who live across our territories, all around the world.

While continuing all its missions and activities, the GSEF carried out in 2024 an important process of consolidation and forward-looking reflection on its political project.

A key effort has also been made to diversify our economic model, to equip the GSEF with the necessary means to meet growing demands for support and to foster the development of SSE around the world.

These steps will complete a period of repositioning and revitalization for the GSEF, enabling us to better address today's many challenges.

In the face of growing obscurantism, we must respond with cooperation and solidarity, and promote education, training, and individual and collective empowerment.

The diversity of our members is a tremendous asset. As a network rooted in local territories and open to the world, the GSEF affirms through each of its actions its commitment to social justice, inclusion, ecological transition, democracy, and peace.

This activity report reflects those commitments: from the development of legal frameworks to the growing recognition of youth voices—these are all strong markers of progress.

The upcoming Global Social and Solidarity Economy Forum in Bordeaux, from October 29 to 31, 2025, will be a moment to demonstrate our unity and call for full recognition and support of SSE values, principles, and actors.

# Introduction

## ◆ Introduction - the GSEF in 2024

The GSEF 2024 Activity Report recounts **the milestones of our organization and the vitality of the actions carried out by the General Secretariat, members and governance**, committed across all continents. These highlights testify of the involvement of members in carrying out initiatives and projects in the field, cooperating to conduct local and regional advocacy, and building public policies favorable to the development of the SSE, in the four corners of the planet.

**From DakarGSEF2023 to BordeauxGSEF2025:** 2024 began with the publication of the Proceedings of the Dakar World SSE Forum, and ended with the launch ceremony at Bordeaux City Hall for the seventh edition of the Global SSE Forum, which will take place in October 2025. **Every two years, the GSEF organizes the Global SSE Forum**, which has become a key event for all players, academics and governments, committed to demonstrating that an economy that serves people and protects nature is already present in all sectors of the economy. The Forum strengthens cooperation and calls on governments and international institutions to support an effective and massive change in the scale of the SSE, and to commit to achieving the 17 Sustainable Development Goals.

Organized just a few days after the adoption of the first United Nations resolution recognizing the role of the SSE, the Sixth edition of the Forum, held in Dakar, supported the dynamic of recognition and development of the SSE on the African continent. We'll come back to this strong momentum in Africa, as well as to other continental dynamics, endogenous and rooted in the territories. These include the creation in January 2024 of RIFESS, the Ibero-American SSE Network, comprising 6 countries, the organization of the 1st FORA'ESS in Yaoundé, the vote on the law recognizing the SSE in Brazil, and the adoption of the African Union's Ten-Year SSE Strategy.

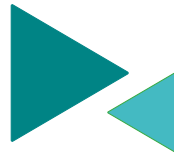
The SSE is rooted in territories, towns and countryside. Its players build social cohesion at local level, encourage cooperation and play an essential role in ecological transition and regional development. They have demonstrated their considerable capacity to adapt, enhanced by their ability to join forces with other local players. The GSEF was founded in response to this realization of the power of the SSE in local economic and social development.

The creation of the GSEF in 2013 was an important step in the international recognition of the social economy as a strategic vector for the social and ecological transition of cities and territories. An initiative of the Seoul Metropolitan Government, the GSEF stands out from existing international SSE initiatives and networks. Its focus on the role of local governments is a clear affirmation of their crucial role in the governance and resolution of the major challenges of the 21st century, be they climate change, social cohesion or inequalities. Its structure, based on a fundamental partnership between local governments and civil society, is also a clear statement in favor of the renewal of democratic processes and the need for a better balance between the private, collective and public sectors.

Since its creation, the GSEF has been convinced that systemic change begins at local level, based on a partnership between civil society and the public and private sectors, with the ambition that SSE should scale up and become the norm for tomorrow's economy, integrating collective management of the commons.



The GSEF is seen as an important force for convergence, through its many partnerships and links with other international networks, as well as a force for action. The GSEF cooperates with international networks, which are also members, while respecting the expression of the diversity and identity of each and seeking to complement each other. This collective action enables us to join forces to promote the SSE and, with it, a change in development models.

## Governance and network animation

The City of Bordeaux and the Regional Chamber of Social and Solidarity Economy of Nouvelle-Aquitaine (CRESS N-A) have held the Co-Presidency of the GSEF since October 2021. This Co-Presidency embodies the diversity of the network's membership — local governments, networks of municipalities, SSE actors, NGOs, universities — and reflects a shared vision based on inclusive dialogue for the co-construction of public policies that support the development of the SSE, and on territorial cooperation to meet fundamental community needs at the heart of inclusive and sustainable economic development

Ensuring the proper functioning of internal governance and the animation of a global network of 87 members is a daily challenge. Strengthening network engagement and cohesion remains a top priority for 2025. We must continue building a shared identity and nurturing a strong sense of belonging.

In line with its charter and values, the GSEF is committed to democratic governance and aims to:

- Support the members of the Steering Committee in leading the network politically;
- Empower the Steering Committee to play an active role in GSEF's strategic direction;
- Reinforce the role of continental co-presidents in amplifying GSEF's advocacy and global outreach;
- Ensure the participation of all members in the network's life and mission;
- Recognize and value the active involvement of members in the GSEF.

The election of the current Steering Committee took place during an Extraordinary General Assembly in November 2023. Members were elected for a two-year term and are responsible for guiding the organization through to the BordeauxGSEF2025 Global Forum.

## 5 MEETINGS OF THE STEERING COMMITTEE

In 2024, **the GSEF Steering Committee** met five times: four quarterly meetings and one special session, all held online with English-French simultaneous interpretation.

• January 16 • April 3 • September 11 • October 17 (Special Session) • December 12

The Steering Committee is composed of 20 elected members of the GSEF for a two-year term, including the two Co-Presidents and the eight Continental Co-Presidents. The members represent equally local governments and SSE organizations.

## TOWARDS A REVISION OF THE GSEF CHARTER

Twelve years after its creation, the GSEF launched a major initiative in 2024: the revision of its founding Charter. In light of the network's growth, evolving internal dynamics, and a changing international context, this reform aims to clarify the GSEF's political foundations and adapt its governance to today's challenges.

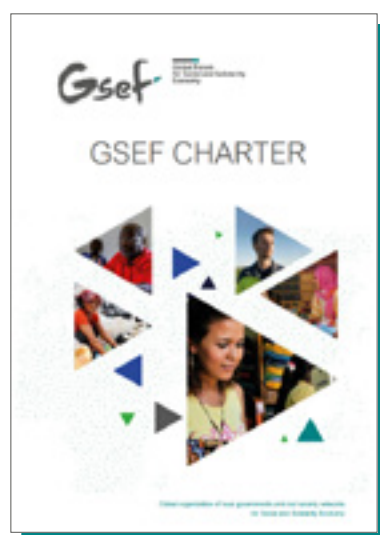
It is about reaffirming the identity of the GSEF — a space for cooperation between local governments and SSE actors — while strengthening member participation, rethinking governance, and fully integrating new voices within the network: youth, thematic networks, and strategic alliances.

This process will result in two distinct documents: **a renewed political Charter**, articulating shared values, vision, and mission; and **updated Bylaws**, defining the rules for membership, representation, and governance.

An **international working group** was established following a special session of the Steering Committee on October 17, 2024, and is currently leading this process. The group brings together members of the Steering Committee, the Advisory Committee, and the GSEF Secretariat. It has already met twice between November and December.

The work is organized in two phases: the first focuses on the Charter, and the second — starting in April 2025 — will address the Bylaws. Throughout the process, GSEF members and the Steering Committee will be actively engaged through consultations, feedback loops, and successive meetings.

The final vote on both documents will take place at the GSEF General Assembly on October 30, 2025, in Bordeaux, during the BordeauxGSEF2025 Global Social and Solidarity Economy Forum.

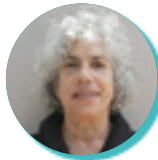

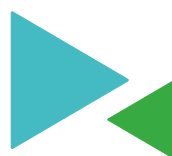

# Governance and network animation

The GSEF is grounded on the sharing of experiences and inspiring innovations across borders, capable of addressing the major social, economic, and environmental challenges faced by territories. It places the Social and Solidarity Economy at the service of communities and local governments by mobilizing resources, expertise, awareness-raising tools, and training to support the emergence of public policies in favor of SSE.

Animating the network of members and partners is a core pillar of GSEF's action. It is built on two complementary dimensions:

- ♦ **A continental dynamic**, led in close collaboration with elected continental co-presidents, rooted in regional realities ;
- ♦ **A thematic dynamic**, coordinated with members, the GSEF Advisory Committee experts and partners, enabling in-depth work on major transversal issues of SSE.

## CONTINENTAL DYNAMICS

Led by the **continental co-presidents** elected in 2023, the continental dynamics embody GSEF's strong commitment to decentralization and grounding in territorial realities. They represent a key pillar of network animation by creating structured spaces of cooperation at every continental level.

In 2024, in-depth work was carried out with the co-presidents to develop and implement **continental roadmaps**. Presented during the April meeting of the Steering Committee and discussed through continental dialogues, these roadmaps identify GSEF's strategic priorities per continent in terms of advocacy, mobilization, and project implementation.

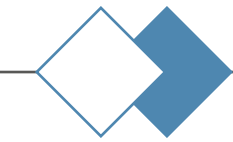
Each roadmap includes:

- A calendar of major events to support member participation and visibility ;
- A mapping of actions organized or supported by GSEF, to facilitate planning and funding ;
- A list of associated researchers and experts ;
- Key advocacy themes and target to reach out ;
- The needs and expectations expressed by members, aligned with GSEF's areas of action.

Two cross-cutting themes underpin all the roadmaps: youth engagement, and the inclusion and empowerment of women in SSE organizations.

**Continental dialogue meetings**, organized on average twice a year, either virtually or in person, are key spaces for exchange, coordination, and mutual learning among members. Agendas are co-developed with members under the leadership of the continental co-presidents.

This section of the report offers an overview by continent of the key events and highlights of 2024, the priorities of the 2024–2025 roadmaps, and member spotlights that illustrate the diversity of SSE contexts across the globe.



## IN NORTH AMERICA



### Continental Co-Chairs

In 2024, the dynamic in North America was structured around the priorities defined in the continental roadmap, under the coordination of the Chantier de l'économie sociale, GSEF continental co-president for the region.

These priorities aim to:

- ▶ Ensure that the universal definition of the SSE set out in the United Nations resolutions (2023 and 2024) and ILO recommendations is put into practice ;
- ▶ Strengthen the sense of belonging to SSE in English-speaking Canada and the United States, by developing partnerships with existing networks ;
- ▶ Support the structuring of a network of cities committed to SSE, following the example of inspiring initiatives led in South Korea (SSEGOV), France (RTES), or Cameroon (REMCESS), by documenting strategies and fostering exchange between municipalities.

These long-term initiatives aim to consolidate a shared vision of SSE at the North American level, drawing on Quebec's vibrant ecosystem and strengthening cross-border synergies.

### Toward the Social Economy Summit in Quebec

On May 14 and 15, 2025, Montréal will host the Social Economy Summit, a milestone event for the future of the movement in Quebec. Led by the Chantier de l'économie sociale, GSEF continental co-president for North America, the Summit is part of a broad co-construction process.

In collaboration with many strategic partners, the preparatory work aims to develop a collective vision, formulate concrete proposals, and launch new structuring initiatives around key themes: socio-ecological transition, equity and employment, local governance, shared real estate, food, culture, environment, inclusion of older adults, and entrepreneurial succession.

The Summit will be a moment of commitment for public authorities, citizen organizations, and social economy networks, with the ambition of strengthening alliances, anchoring progress, and raising the profile of SSE in Québec and beyond.

### Continental Co-Chairs

Since the Global SSE Forum held in Dakar in May 2023, the African dynamic around SSE has significantly intensified. In 2024, GSEF committed to supporting this momentum by backing the priorities collectively defined by its members and strengthening structuring partnerships led by actors across the continent.

**Two major events** marked 2024:

#### FORA'ESS – First edition of the African Forum on the Social and Solidarity

From May 29 to June 1, 2024, the city of Yaoundé in Cameroon hosted **the first edition of FORA'ESS**.

Born from the dynamic launched at DakarGSEF2023, this continental gathering brought together **over 1,000 participants from 30 African countries**. Designed as a political and territorial response to the continent's challenges, it is intended to become a biennial event alternating with GSEF Global Forums.

GSEF actively supported the organization of the event, notably through its African co-president Malick Diop from the Platform of Non-State Actors of Senegal, and REMCESS – Network of Mayors of Cameroon for SSE.

Several highlights shaped this first edition, including:

- ▶ **The mayors' panel**, bringing together representatives from Dakar, Bordeaux, Olanjuana, Golf-Sud, ARDCI, Kibouende, and the Regional Council of the Oriental Region ;
- ▶ **Workshops and plenaries** co-organized by REMCESS, GIZ, FEICOM, and GSEF, focused on responsible public procurement and support for youth and women entrepreneurship.

**Four texts were adopted**, including the Final Declaration of FORA'ESS and the Declaration of Local Authorities decentralized, reflecting the collective commitments made on this occasion.

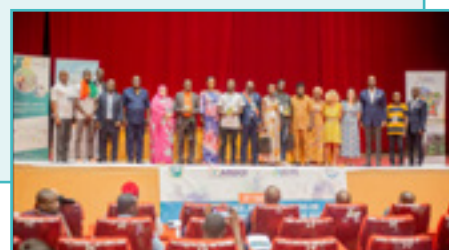


#### 2nd Young Leaders Forum on SSE

The second edition of the Young Leaders Forum on SSE was held from October 29 to 31, 2024, in Yamoussoukro, Ivory Coast, under the leadership of Fabrice Balou, co-pilot of the SSE Youth Hub for Africa.

This event helped strengthen the involvement of African youth in transformation dynamics aligned with GSEF's priorities.

## Perspectives

The year was also marked by the adoption by the African Union of a ten-year continental strategy on SSE. The GSEF will support its dissemination and implementation through partnerships with local governments and networks.

In addition, GSEF was called upon in several countries to support the development of SSE ecosystems: assistance with policy design, training activities, support for network structuring, and job creation for youth. In 2024, it supported the organization of national SSE conferences in Ivory Coast and Benin.

## Focus on two GSEF members from Africa

### ► City of Dakar – Local government (Senegal)

*Member of the Steering Committee & Continental Co-president – Africa*

The City of Dakar plays an active role in developing local public policies in support of SSE, in close collaboration with civil society networks and national authorities. It also contributes to GSEF's continental activities, notably through its involvement in regional dialogues and major African events.

#### **SSE Context – Senegal**

Senegal has made major strides in the institutional recognition of SSE, with the creation of a dedicated ministry in 2017, followed by the adoption of a framework law in 2021. The country benefits from a dynamic ecosystem where cooperatives, associations, and local economic groups strengthen social cohesion and territorial development.

#### **Strengths**

- Solid institutional framework (ministry, framework law)
- Strong mobilization of local authorities
- Diversity of legal forms of SSE across the territory
- Active international partnerships

#### **Challenges**

- National strategic coordination still to be strengthened
- Lack of suitable infrastructure and qualified human resources
- Weakness of financing tools dedicated to SSE

### ► Regional Council of the Oriental Region – Local government (Morocco)

*Member of the Steering Committee*

The Regional Council of the Oriental Region is an active GSEF member and a key actor in developing SSE in Morocco. Its action is part of a favorable national framework, particularly through the law on cooperatives (112.12). The region is notable for its strong cooperative dynamic, especially in agriculture, and for the significant participation of women in urban areas.

#### **SSE Context – Morocco**

SSE in Morocco is built on a dual foundation: age-old community traditions (touiza, jemaa) and a developing cooperative framework. A forthcoming framework law currently being drafted should further strengthen this momentum.

#### **Strengths**

- Strong development of the cooperative spirit (women, young beekeepers)
- Existing financial support (regional and national levels)
- Large pool of cooperatives structured by sector
- Significant job creation potential

#### **Challenges**

- Laws still poorly adapted to field realities
- Limited technical support before and after launching activities
- Difficult access to infrastructure meeting regulatory standards



## IN EUROPE



### Continental Co-Chairs

The European dynamic of GSEF is part of a long-term strategy aimed at making SSE a lever for economic The momentum of SSE in Europe has been driven for many years by countries such as Spain, France, Belgium, Italy, Portugal, and Luxembourg, with support from the European Commissioner for Jobs and Social Rights Nicolas Schmidt, and confirmed by the adoption of the European Social Economy Action Plan in December 2021.

In 2024, this dynamic focused on consolidating inter-network partnerships, strengthening European advocacy, and actively participating in major political events. GSEF and its members contributed in particular to the European conferences held in San Sebastián (November 2023) and Liège (February 2024), which marked a broadening of the mobilization to new EU countries such as Germany, Bulgaria, and Poland.

In complementarity with longstanding networks such as Social Economy Europe and REVES, GSEF is working to co-construct a common advocacy. In 2025, this advocacy will focus in particular on the implementation of the international dimension of the European Social Economy Action Plan in support of solidarity-based cooperation with countries in the Global South. Another key priority will be the territorial implementation of the job guarantee, in connection with the “Zero Long-Term Unemployed” experiments.

## Focus on two GSEF members from Europe

### ► ConcertES – National network (Belgium)

*Member of the Steering Committee & Continental Co-president – Europe*

ConcertES plays a structuring role in disseminating SSE values and practices in Wallonia. It brings together grassroots actors, represents their interests to public authorities, and actively contributes to the development of regional public policies.

#### **SSE context – Belgium**

The social economy is regulated in Wallonia by a regional decree of 2008. It covers many sectors: ecological transition, social inclusion, housing, short supply chains, reuse, sheltered employment, etc. The region relies on a dense and historically rooted associative fabric, and on structuring public mechanisms such as the SSE Observatory.

#### **Strengths**

- Strong legal framework and dedicated administration
- Reliable data thanks to the SSE Observatory
- Capacity for innovation in diverse sectors
- Alternativ'ES strategy and ambitious communication plan

#### **Challenges**

- SSE still marginalized compared to profit-driven logics
- Low cross-sectoral integration in public policies
- Lack of integration at all levels of governance

#### **Key figures**

- 1 in 8 jobs in Wallonia belong to the social economy
- SSE is present in more than 10 sectors: energy, employment, inclusion, transition...





## ► Nouvelle-Aquitaine Region – Local Government (France)

*Member of the Steering Committee & Continental Co-president – Europe*

The Nouvelle-Aquitaine Region is a pioneer in the institutionalization of SSE. It was the first French region to create an SSE department integrated within the economic development division. It supports the structuring of actors, youth dynamics, and develops cooperation with other regions worldwide.

### **SSE Context – France**

Since the 2014 SSE law, French local governments have a clear framework to develop their public policies in favor of SSE. In Nouvelle-Aquitaine, the dynamic is particularly strong, with initiatives focused on education, support for collective entrepreneurship, and social innovation.

#### **Strengths**

- Dedicated SSE department and political delegation
- Active cooperation with CRESS, ESPER, and the National Education system
- Over 100 organizations in the “Youth & SSE” collective
- Incubation and innovation programs (CJS, Fab’ESS)

#### **Challenges**

- Uneven visibility across territories and sectors
- Need to strengthen integration with ecological transition
- Expansion needed beyond the most advanced areas

#### **Key figures**

- 3rd French region in terms of SSE employment volume
- 246,065 SSE employees, representing 16% of regional private employment
- 19,840 SSE employer organizations
- 1.2 million volunteers in the region

## IN ASIA



### Continental Co-Chair

The continental dynamic in Asia intensified in 2024, driven by the Continental Co-president SSEGOV, in close collaboration with active members in the region.

It is based on a roadmap structured around four priorities: supporting local governments in the integration of SSE, highlighting its impact on the Sustainable Development Goals (SDGs), promoting the United Nations Resolution on SSE, and contributing to the establishment of enabling legal frameworks.

Two continental policy dialogues punctuated the year: the first in May, then a second in December, which marked a key step in consolidating this collective strategy.

### Asia Policy Dialogue – December 2024

Co-organized with the Continental Co-president SSEGOV, the Asia Policy Dialogue of December 2024 brought together 57 participants from 14 countries. It made it possible to:

- ▶ highlight the contribution of SSE to the resilience of Asian territories,
- ▶ share existing public policies in several countries,
- ▶ emphasize key levers for a strong SSE ecosystem: regional advocacy, capacity building, financial innovation..

### GSEF Mission to Seoul

In November 2024, a GSEF mission to South Korea helped strengthen ties with the founding members of the network and support the growing momentum of the SSE dynamic in Asia.

Alongside the Seoul Metropolitan Government, SSEGOV, the SVS Fund, and the Seoul Social Economy Network, the GSEF took part in the National SSE Congress, marking an important step in reviving the historical cooperation initiated in Seoul.

This mission also aimed to actively mobilize Korean partners for their participation in the Global Social and Solidarity Economy Forum Bordeaux GSEF2025, particularly youth networks.

Exchanges were also held with Gyeonggi Province, illustrating the commitment of local governments to structuring ambitious public policies in support of SSE.

## Focus on two Asian members of the GSEF

### ► National Association of Rural Municipalities in Nepal – Network of local governments

*GSEF Member since 2024*

NARMIN brings together Nepal's rural municipalities and works to strengthen the role of local governments in economic development, notably through initiatives close to SSE (agriculture, tourism, cooperatives). The organization advocates for a clearer and more coordinated structuring of these local dynamics, in favor of more inclusive governance.

#### **SSE Context – Nepal**

Although SSE is not formally defined, many areas of intervention—often funded through local budgets—are aligned with its principles. However, the absence of a policy framework hinders their recognition and coordination at the national level.

#### **Strengths**

- Local support for key sectors related to SSE
- Numerous and diverse cooperatives
- Strong community involvement

#### **Challenges**

- Lack of a clear policy framework
- Poorly coordinated initiatives
- Limited institutional capacities

### ► Association for the Promotion of SSE in Japan (APSSE-J) – SSE Network

*Active member of the continental advocacy*

The APSSE-J advocates for the institutional recognition of the SSE in Japan. Its action focuses on strengthening territorial solidarity and promoting cooperatives as key drivers of more equitable development, especially in rural areas experiencing a decline in vitality.

#### **SSE Context – Japan**

The country benefits from a dense cooperative network, but SSE is little recognized as such by public authorities. The main challenge lies in the sector's visibility and the mobilization of structured advocacy.

#### **Strengths**

- Strong cooperative potential
- Growing commitment from local authorities
- Local heritage of territorial solidarity

#### **Challenges**

- Lack of official recognition of SSE
- Weak coordination among stakeholders
- Still limited awareness among stakeholders

## IN LATIN AMERICA AND THE CARIBBEAN

### Continental Co-Chair

In 2024, the continental dynamic in Latin America and the Caribbean was structured around an ambitious roadmap, led by our continental co-pilot INAES Mexico and collectively developed with members from the region.

This strategy is based on five priorities: raising awareness among local and national governments about SSE ; strengthening youth mobilization ; promoting the definition of SSE adopted by the United Nations; demonstrating its contribution to achieving the Sustainable Development Goals (SDGs) ; and supporting knowledge production as well as intergovernmental dynamics such as RIFESS – the Ibero-American Network for the Promotion of SSE.

GSEF actively contributed to several key moments on the continent in 2024, strengthening its institutional presence and consolidating synergies with movements, universities, governments, and historic SSE networks.

### COP16 Biodiversity and ECOOVIDA2024

In October 2024, the GSEF attended the 16th United Nations Biodiversity Conference (COP16) in Cali, Colombia. Céline Papin, Deputy Mayor of Bordeaux, participated in a panel on “Women and Biodiversity” to present the SSE policies of the City of Bordeaux, notably in favor of women's employment, and to highlight GSEF's leadership commitment to social and ecological transitions through territorial cooperation.



At the same time, GSEF participated in ECOOVIDA2024, the international gathering of “economies for life,” held from October 22 to 26 and organized by Unidad Solidaria with the support of numerous networks: FSMET, RIPESS, COLACOT, MAELA, RULESCOOP, International SSE Forum, Via Campesina... Over 3,000 participants came together around thematic forums, political plenaries, solidarity journeys, and convergence spaces.

GSEF took part in the opening plenary, facilitated two sessions on international instruments for SSE, and collaborated with its member, the Cooperative University of Colombia, on the forum “Popular and Community Education.”

The meetings resulted in the adoption of an International Pact of Economies for Life, calling for the concrete implementation of the UN Resolution on SSE and the creation of a dedicated Global Observatory.

### Towards new cooperations in Brazil

The GSEF and the city of Maricá in Brazil have initiated a collaboration following their visit to Bordeaux in June.

The Secretary General herself traveled to Maricá in November to participate in the SSE conference, EGAPES, organized by the City of Bordeaux. She notably visited CODEMAR and Banco Mumbuca. A letter of intent was signed between GSEF and the city to consolidate the partnership and the city's membership in the GSEF.

## Ibero-American Network for the Promotion of the Social and Solidarity Economy

The **RIFESS** was created in Mexico City in January 2024, in response to the historic adoption by the UN of the first resolution recognizing SSE as a lever for sustainable development. Its objective: to encourage public policies that support this economic model rooted in territories and non-relocatable.

Led by the governments of Spain, Brazil, Chile, Colombia, Guatemala, and Mexico — soon to be joined by Portugal and Cuba — this network fosters the structuring of an SSE ecosystem bringing together cooperatives, worker-owned enterprises, mutuals, integration companies, specialized employment centers... It promotes the full integration of these structures into regional economies, following a logic of solidarity and sustainability.

The RIFESS embodies a strong political vision: according to Spain's Minister of Labour, Yolanda Díaz, this network is "a cooperation instrument that will strengthen democracy and social justice in all Ibero-American countries." It offers a credible economic alternative to the current global disorder, placing equitable wealth distribution, community sovereignty, and decent work at the heart of its commitments.

GSEF supported this initiative from its inception and participated in the **Ibero-American Seminar on Social and Solidarity Economy, co-organized by INAES Mexico and the RIFESS**. The event, broadcast live to widen its reach, brought together national and international public institutions committed to promoting local, sustainable, and inclusive development, centered on concrete cooperations.

### Focus on two Latin American members of GSEF

#### ► **ISTEPS – Higher Technological Institute of Popular and Solidarity Social Economy (Ecuador)**

*Member since December 2024*

ISTEPS, based in Cuenca, is a key academic player in Ecuador. It works to professionalize the SSE sector through training, applied research, and partnerships with producer organizations.

##### **SSE Context – Ecuador**

The SSE has been enshrined in the Constitution since 2008 and governed by an organic law from 2011. It plays a strategic role in rural territories and with vulnerable populations. The region relies on a dense and historically rooted associative fabric, as well as on structuring public mechanisms such as the SSE Observatory.

##### **Strengths**

- Strong legal framework (Constitution, 2011 law)
- Well-structured producer networks
- Potential for training and social innovation
- Active public/community cooperation

##### **Challenges**

- Competition with the informal sector
- Still limited visibility compared to the private sector
- Need to strengthen support and technological resources

#### ► **Mexico City – Local Government (Mexico)**

*Member since 2018, host of GSEF2021*

Mexico City develops SSE support policies linked to working-class neighborhoods, collective enterprises, and cooperatives. It relies on an ambitious SSE law and a dedicated public agency: INAES.

##### **SSE Context – Mexico**

The SSE is governed by the 2012 SSE law and anchored in Article 25 of the Constitution. It includes a wide range of cooperative, community, and solidarity organizations.

##### **Strengths**

- Clear legal framework (SSE + cooperatives)
- Technical and operational support through INAES
- Multi-stakeholder partnerships across 32 states
- Significant economic weight of the sector

##### **Challenges**

- Institutional recognition still to be consolidated
- Inequalities in access to training and financing
- Direct competition with private sector actors



## THEMATIC WORKING GROUPS

The GSEF develops a structured thematic animation strategy to foster collective and operational expertise on SSE issues. Through working groups co-led by its members and experts, the network promotes peer-to-peer learning, the sharing of local public policies, and the capitalization of inspiring practices at the international level.

These thematic dynamics aim to:

- ▶ foster technical cooperation between members on key topics;
- ▶ organize webinars, meetings, and joint productions;
- ▶ support the development of advocacy based on grassroots experiences;
- ▶ and bring together contributions from researchers and practitioners to support systemic transformation.

This section highlights the working groups active in 2024, their progress, ongoing outputs, and the upcoming valorization of their work at the BordeauxGSEF2025 Forum.

**Access to appropriate finance remains a major challenge for SSE, especially in emerging countries. This group is working to identify innovative models of solidarity financial intermediation, aligned with SSE values.**

As a result of a **partnership between GSEF and FAIR**, a **study** funded by the French Ministry for Europe and Foreign Affairs is underway to highlight concrete approaches driven by a variety of actors. It explores governance mechanisms, partnership models, value distribution, and the sustainability conditions of these mechanisms. Conceived as a practical and strategic tool, the study targets financial institutions, public decision-makers, and practitioners. It will be presented at the BordeauxGSEF2025 Forum, complementing the work of the UNTFSSSE to strengthen international convergence in favor of finance serving the SSE.

**This group explores the links between public action and systemic transformations through the lens of SSE.**

In 2024, the group launched an international call for contributions to document concrete experiences across various territories. Result: over 40 proposals received and reviewed by a reading committee composed of experts from the group. A selection of case studies was finalized at the end of the year, offering a rich panorama of the dynamics underway.

In 2025, these texts will undergo a rigorous editorial process ahead of their **joint publication at the Bordeaux GSEF2025 Forum**. This unique tool aims to support the institutional recognition of SSE within public policies contributing to the SDGs.

**Local governments have a key role to play in turning public procurement into a lever for social, environmental, and economic transformation serving the SSE. This inter-continental working group maps out good practices, legal frameworks, and inspiring local initiatives.**

Its objective? To feed international advocacy, equip public authorities, facilitate access to public contracts for SSE stakeholders, and disseminate a shared culture of responsible procurement. It supports local and international dynamics through active participation in various events (BEE Forum, FORA'ESS, Local Economic Development Forum in Seville...).

**A comparative study** will be published at the BordeauxGSEF2025 Forum, enriched with practical examples and an actionable tool for local adaptation.



# The GSEF SSE Youth Hub



Since its creation in 2013, the GSEF has consistently recognized the importance of youth engagement in the Social and Solidarity Economy. Through international events, impactful advocacy, and structured continental dynamics, the GSEF highlights the key role played by youth in driving social, economic, and environmental transitions.

The GSEF SSE Youth Hub is an international space for convergence that mobilizes, connects, and uplifts young people from all over the world around the SSE, promoting it as a lever for social, ecological, and democratic transformation.

At the GSEF2023 General Assembly in Dakar, and following the call made during the SSE Youth Pre-Forum, the creation of the SSE Youth Hub was formally adopted to recognize youth as central actors in scaling up the SSE.

This hub articulates its action around **three pillars**:

## 1 AWARENESS

Promoting SSE values among young people and strengthen the SSE Youth community

## 2 ADVOCACY

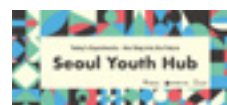
Valuing their role as agents of just transitions

## 3 SUPPORT

Empowering youth-led projects through platforms, incubators, and cooperatives

The SSE Youth Hub is co-led by GSEF members on each continent, who define continental action levers to advance these three pillars.

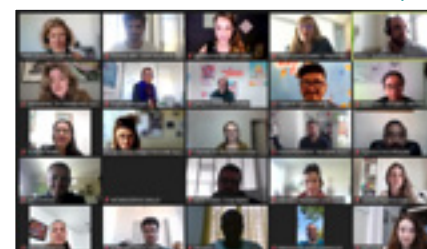

## Official launch

The SSE Youth Hub was officially launched on April 12, 2024, during **a webinar** gathering more than 150 participants from 37 countries across 5 continents.

This launch embodies both the culmination of a historic commitment by the GSEF to youth, and the beginning of a new dynamic: a structured space for international cooperation, designed to coordinate youth-led initiatives, strengthen their visibility, and assert their driving role in the future of the SSE.

## KEY HIGHLIGHTS OF THE SSE YOUTH HUB ACROSS CONTINENTS

### AFRICA



#### 2nd Edition of the Young Leaders Forum on SSE

October 29–31 – Yamoussoukro, Ivory Coast

The second edition of the Young Leaders Forum on SSE brought together over 400 participants from 17 countries across Africa, Europe, North America, and Latin America. Its objective was to strengthen a pan-African community committed to the SSE. The event was co-organized by ARDCI (Assembly of Regions and Districts of Ivory Coast), Abewe, and the GSEF SSE Youth Hub, in partnership with local and international stakeholders.

The discussions led to a series of structural recommendations around four main priorities:

- ▶ a favorable legislative framework for youth-led SSE initiatives ;
- ▶ incentive measures (support funds, access to public procurement) ;
- ▶ capacity building and the creation of an African network of incubators ;
- ▶ stronger recognition of SSE through data, volunteering, and the SSE Youth Initiative Booklet, showcasing 40 innovative projects led by young people from 8 countries.

#### Supporting the SSE Youth Hub in Africa



**Fabrice Adelphe Balou**, a long-standing GSEF member since 2017 and a key figure in the promotion of SSE in Africa, is a major driving force behind this dynamic. In Ivory Coast, his advocacy contributed to drafting the national SSE law, set to be adopted in 2025. He organized the first Young Leaders Forum on SSE in Grand-Bassam in 2021, mobilized youth focal points to ensure the active participation of young people from several countries in DakarGSEF2023, and coordinated the second edition of the Young Leaders Forum in Yamoussoukro. Marked by strong institutional recognition, the event also provided the opportunity to establish strategic partnerships, notably with the signing of MoUs with the ARDCI and France Volontaires. Currently serving as Africa Lead of the SSE Youth Hub within the GSEF, through the organization ABEWE, he leads a dynamic network of 17 national Youth Focal Points, implements the recommendations issued from the Forum, and is preparing the third edition of the Young Leaders Forum on SSE to be held in 2026 in DRC.

### ASIA



The GSEF took part in the Ecopeace Forum (DMZ Open Festival, South Korea) at the invitation of its member NEXT-G, the Korean youth network dedicated to SSE. The youth social entrepreneurs panel highlighted the key role of young people in addressing ecological and social crises, and emphasized the importance of local and international cooperation. These exchanges helped strengthen the mobilization around the SSE Youth Hub in Asia on the road to BordeauxGSEF2025. [Learn more](#)

This gathering allowed them to voice their expectations for the BordeauxGSEF2025 Forum. Several strong priorities emerged: training, mental health, technological innovation, agroecology, fiscal justice, recognition of traditional knowledge, political participation, and the co-construction of public policies.



# The GSEF SSE Youth Declarations

## Global Youth Camp for SSE – Seoul 2017

### Read the declaration



At the initiative of GSEF, 100 young people from 25 countries laid the foundation for a global movement toward an economy that serves both people and the planet. This first declaration asserted that SSE is a concrete lever for achieving the SDGs, transforming territories, and renewing economic democracy. Participants championed a vision based on cooperation, solidarity, equality, and shared governance.

In response to dominant models, they called for ambitious alternatives driven by youth. SSE was embraced as a space of engagement and collective action, where everyone can contribute to a fairer society. The declaration emphasized the need to create spaces for empowerment, knowledge sharing, and collective leadership.

Four priorities were highlighted: decent work as a tool for emancipation; local communities built on collective action; housing as a pillar of sustainable human development; and solidarity finance rooted in social justice.

The message was clear: “Just do it and smile.” The change starts here, with us.

## BilbaoGSEF2018

In Bilbao, youth called for SSE to become a truly inclusive space, where their voices are heard, acknowledged, and structurally integrated. Faced with crises and precarity, young people affirmed that decent work is a gateway to a more equal and solidarity-based economy. They promoted a vision grounded in participation, collaboration, social justice, and environmental impact.

They firmly rejected symbolic participation and called for meaningful involvement in the governance of SSE events, networks, and structures. The challenge is not about “talking about youth,” but making space for a generation that is active, legitimate, and committed.

Three levers were proposed: set a clear participation goal of at least 35% of under-35s in international events; support the creation of an international youth network for SSE; and ensure active representation of youth from the Global South, too often excluded from global dynamics.

Youth are ready to build the future of SSE alongside historic actors. The time for structured and contributing youth has come.

With over 1,000 young people from 25 countries taking part, youth from Latin America and around the world affirmed the centrality of SSE for achieving the SDGs. Driven by a spirit of convergence, the declaration called for increased visibility of SSE, recognized it as a space for collective action, and advocated for embedding its principles in education and public policies.

Young people defended an SSE that is localized, inclusive, cooperative, and intergenerational. They called for the creation of an independent international youth network and the expansion of spaces for training, dialogue, and knowledge sharing.

Three main areas of work were identified: raising the visibility of SSE through media, education, and civic mobilization ; building community around cooperation, self-management of knowledge and the circular economy ; and fully integrating SSE into youth policies aligned with the SDGs.

Their powerful conclusion: SSE is a lever for social and climate transformation. Youth are committed to it so that “no one is left behind.”

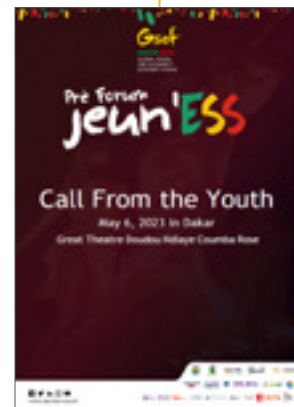
At the close of the Youth & SSE Pre-Forum of the 6th edition of the Global Forum on SSE in Dakar, which brought together 3,000 people from over 30 countries, youth from Africa and beyond issued a powerful call : SSE entrepreneurship means transforming the world. Organized by and for youth, this gathering highlighted initiatives, created spaces for expression, and collectively built a political advocacy.

Young people called for an SSE centered on life, solidarity and sustainability, and asked for a change of scale. To achieve this, they urged governments, GSEF, and partners to co-build a fairer, more inclusive, and more accessible ecosystem.

Among the priorities raised:

- ▶ Create a support fund for youth projects, coordinated by a permanent SSE Youth Commission ;
- ▶ Establish the SSE Youth Hub and integrate youth into SSE public policies ;
- ▶ Enhance youth mobility, strengthen training, and develop tailored financial tools.

Their strong conclusion: youth want to be part of the decision-making process, both locally and in international institutions. They called for intergenerational justice and gender equality to be treated as central and cross-cutting priorities at future Forums.

## # Bordeaux GSEF2025

**On track to BordeauxGSEF2025**

As we head toward the BordeauxGSEF2025 Forum, the year 2024 has laid the groundwork for an ambitious and international youth mobilization. In line with the four historic youth declarations since 2017, a structured advocacy process is now underway on each continent. Its objective is to make the voices of youth heard, reflecting the diversity of lived experiences across the globe, and rooted in the local challenges, national frameworks, and territorial dynamics of the SSE.

Each continent is leading its own independent process of mobilization and consultation. These approaches, embedded in African, Latin American, Asian, North American, and European contexts, aim to build collective advocacy led by and for youth, with messages grounded in their concrete realities. They ensure that youth voices are representative, diverse, and deeply rooted in their territories.

To strengthen global coordination, a new International Solidarity Volunteer (VSI) will join the GSEF Secretariat team in early 2025. A European application has also been submitted to support youth mobility across Europe, and several funding proposals have been developed to ensure inclusive and equitable participation of youth from all continents at the Forum.

This process will culminate in Bordeaux with a powerful political and symbolic moment : youth from around the world will come together to share their demands, present their proposals, and co-construct an **International Youth Declaration for SSE**. This declaration will be presented during the official closing ceremony, affirming that youth is not a marginal theme, but a cross-cutting, collective, and structuring force for transforming the economy—today and into the future.

Since its creation, the GSEF has promoted the values and potential of the SSE at the global level. Through its international advocacy efforts, the GSEF has contributed to the historic momentum for the recognition of SSE within the international agenda.

In 2024, the GSEF continued its advocacy towards States and local governments, calling for ambitious public policies, and will pursue its support for the development of enabling ecosystems for SSE across the world.

The GSEF consistently demonstrates that SSE is a tool for democracy in territorial development—at the heart of responses to social needs, protection, and the fight against exclusion and poverty. SSE fosters long-term capacities for cooperation and citizen-led transitions, rooted in local territories and driven by civil society.

### The GSEF continues to expand its influence and collaboration with international institutions and organizations.

For years, the GSEF has worked closely with numerous international, regional, and national SSE networks, as well as global organizations such as the United Nations Inter-Agency Task Force on Social and Solidarity Economy (UNTFSE), the International Labour Organization (ILO), the European Commission, the Organisation for Economic Co-operation and Development (OECD), and United Cities and Local Governments (UCLG), to promote the international recognition of SSE. In 2024, the United Nations General Assembly adopted a new resolution entitled “Promoting the Social and Solidarity Economy for Sustainable Development”, with 175 votes in favor. The text reaffirms the importance of SSE in achieving the Sustainable Development Goals through inclusive and resilient growth.

As an observer of the UNTFSE, the GSEF welcomes the adoption of this resolution and expresses its gratitude to the sponsoring countries. The resolution explicitly mentions BordeauxGSEF2025, the upcoming Global SSE Forum, as a key international milestone in support of its implementation.

Inter-Agency Task Force on

**The GSEF has been an active observer of the United Nations Inter-Agency Task Force on Social and Solidarity Economy (UNTFSE) since 2017** and takes part in all of its meetings, held every two months via videoconference. As of November 2023, the Task Force included 17 members (UN agencies and the OECD) and 13 observers.

As a reminder, the UNTFSE was established in 2013 in response to growing concern within the United Nations system about the need to rethink development in the wake of multiple global crises and in the context of the post-2015 development framework and the 2030 Agenda for Sustainable Development.



## First Anniversary of the United Nations Resolution on the Social and Solidarity Economy and the Sustainable Development Goals

The GSEF marked the first anniversary of the United Nations General Assembly Resolution recognizing the role of the Social and Solidarity Economy in achieving the Sustainable Development Goals — adopted on April 18, 2023 — by launching a dedicated social media campaign.

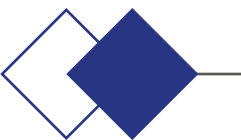

### The GSEF is expanding its presence and advocacy with networks of cities and local governments: UCLG et World Forum of Local Economic Development

The GSEF has continued its advocacy with networks of cities and local governments to make SSE a priority in local public policies and action plans. To this end, the GSEF reinvests in spaces for reflection and exchanges among local governments on transitions and local economic development.

In 2023, the GSEF renewed its collaboration with FAMSI, which is organizing, for the United Cities and Local Governments network (UCLG), the 6th Global Forum on Local Economic Development (LED) in early 2025 in Seville. The GSEF is a member of the Forum's organizing committee.

The GSEF has also renewed its support for a community of practice within UCLG. Indeed, the City of Bordeaux (Céline Papin, Deputy in charge of International Relations) is an elected member of the global secretariat and applied in Daejeon in October 2022 to lead this community of SSE practice exchanges through its presidency of the GSEF. The priority in 2024 will be to revive the animation of this group.

The GSEF has established a strong brand image in promoting and supporting the development of local and regional ecosystems as part of the overall Social and Solidarity Economy strategy. The added value of the GSEF, compared to other networks, lies in its emphasis and understanding of the necessity for continuous partnership and dialogue between civil society and municipal governments, and in its ecosystem approach.

Panels of mayors and other local government representatives are organized at each Global Forum of the GSEF. These political highlights are anticipated moments where elected officials share their commitments to support the development of SSE.

Cities and local governments in general are eager to play an active role in implementing the SDGs and measuring the results of their public policies against the SDGs. Decentralization reflects different realities from country to country and has transferred responsibilities to local authorities.

The development and scaling up of SSE will only be possible with the engagement of local governments.

### Secretariat of the International Coalition of the Social and Solidarity Economy

In 2024, the GSEF continued to serve as the Secretariat of the International Coalition of the Social and Solidarity Economy (ICSSE).

Formed in 2021, the Coalition brings together five global SSE networks to strengthen international advocacy and ensure the voice of SSE actors is heard in global debates.

The Coalition held five regular meetings in 2024.





## The GSEF is expanding into new spheres of influence: URBAN 20 in Rio - G20

In August 2024, the GSEF applied to organize an SSE conference during URBAN 20, organized by UCLG and C40, ahead of the G20 summit.

This application followed the declaration of the G20 Ministers of Labour and Employment in July 2024 in Fortaleza. The declaration repeatedly highlights the Social and Solidarity Economy as a key tool to create decent jobs and commits their countries to promoting public policies that support SSE.



*« [...] 5. We need to strengthen our efforts to foster social inclusion, eradicate multidimensional poverty and address working poverty with a focus on the promotion of quality jobs and decent work, recognizing that the social and solidarity economy could play an important role in generating quality employment, promoting fair working conditions and environmental sustainability with job creation in just transition processes.*

*6. We stress the importance of strategies to create and promote decent work and deliver effective labour market policies, such as skills development, access to training and lifelong learning and job matching, aligned with the skills needs and demands of the economy and in consultation with social partners. Similarly, we will promote policies that foster the SSE. »*

The GSEF has advocated for the development of ambitious public policies with states and local governments: 25 countries have adopted an overall legal framework to support the development of SSE actors. Major progress could therefore be made quickly with the commitment of G20 countries to enable the scaling up of SSE and to support the development of SSE-friendly ecosystems at the global level. The session was composed of SSE experts, local governments, and practitioners actively engaged in the development of SSE (impact of their practices, projects, and public policies on promoting SSE ecosystems).

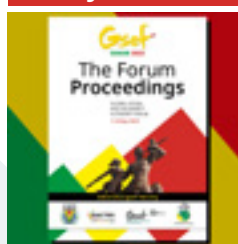

## Niort, France

### National Forum on Social and Solidarity Economy and Social Innovation

The GSEF participated in the National Forum on SSE in France, co-organized by CRESS Nouvelle-Aquitaine and the Nouvelle-Aquitaine Region. This edition marked the 10th anniversary of the French SSE Law, with a strong call to build a unified political voice to scale up SSE.

GSEF co-led the closing plenary alongside its co-presidents (CRESS Nouvelle-Aquitaine and the City of Bordeaux), stressing the urgency of supporting local and national authorities in implementing international recommendations adopted over the past three years. Key members and partners were also present: ConcertES, Social Economy Europe, ESS Forum International, the OECD, and the European Commission.

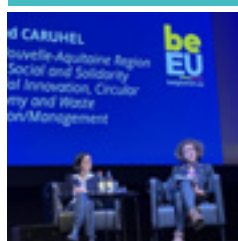
Another key moment was the roundtable on international recognition of SSE, featuring SENS Benin, CRESS Mayotte, and ESS-France Overseas, bridging global perspectives with concrete local actions.

The event saw strong international mobilization, with delegations from Burkina Faso, Belgium, Cameroon, Senegal, Togo, Benin, Madagascar, Quebec, Morocco, Tunisia, Algeria, and Ivory Coast. GSEF also reunited with numerous members and allies: the Ivorian SSE Network (RIESS), L'Envol, the Zodo Action & Solidarity Network (RÉZAS), and the RTES Network. A bilateral meeting between the Moroccan region of Souss Massa and Nouvelle-Aquitaine helped strengthen dialogue on local SSE policies.

Lastly, a workshop dedicated to BordeauxGSEF2025 marked the launch of the local dynamic, setting the tone for a Forum that values interculturality and broad stakeholder engagement.

### Anniversary of the United Nations Resolution on SSE — #1yearSSEUNResolution

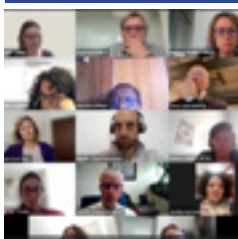
On the first anniversary of the historic UN General Assembly resolution recognizing the role of the Social and Solidarity Economy (SSE) in achieving the Sustainable Development Goals, GSEF mobilized alongside the UNTFSSSE (United Nations Inter-Agency Task Force on SSE). An international webinar brought together members and observers to review progress and launch a joint communication campaign highlighting SSE as a driver of sustainable, inclusive, and resilient development.

In parallel, GSEF co-signed a press release with its partners in the International Coalition on SSE (ICSSE) calling on UN member states to accelerate the implementation of the resolution. The text reaffirmed three key priorities : positioning SSE as a lever for achieving the SDGs, strengthening dedicated public policies and legal frameworks, and providing the UNTFSSSE with the necessary means to support this implementation.

GSEF also launched a campaign involving its political leaders, inviting them to speak on the local impact of the resolution. Through a series of inspiring testimonials, co-presidents and members of the network reaffirmed their commitment to turning this international progress into concrete action in their territories. A major visibility moment to showcase the diversity of local approaches to implementing the resolution.

## The GSEF welcomes elected officials from the City of Maricá to Bordeaux

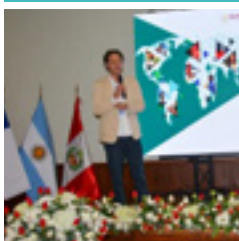

## National Congress on the Social and Solidarity Economy in France

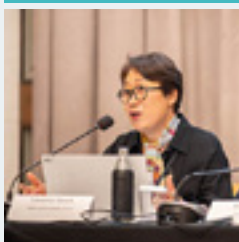
The GSEF took part in the international plenary of the Congress organized by ESS France, marking the 10th anniversary of the French law defining SSE.

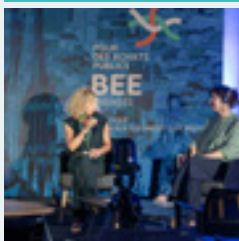
## ILO Workshop: SSE for the achievement of the Sustainable Development Goals in Asia

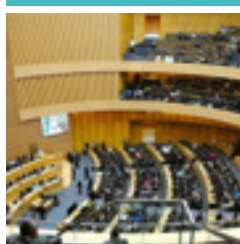
#### **Opening of the call for contributions for BordeauxGSEF2025**

SSE stakeholders, local governments, partners, and institutions from around the world were invited to submit their contributions to shape the program of the 7th Global SSE Forum of GSEF, around the central theme: « SSE as a condition for a just transition toward resilient territories and the well-being of their inhabitants », divided into 7 thematic pillars: just transition, financing, co-construction and innovation in public policy, inclusive prosperity, decent work, empowerment, foresight and research.

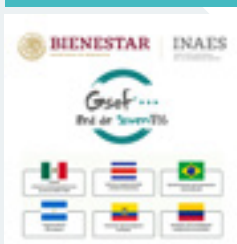

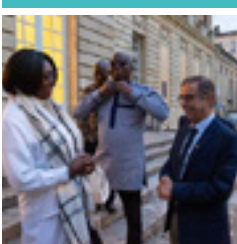
## Launch of the African Cooperative Center by the African Union (AU)

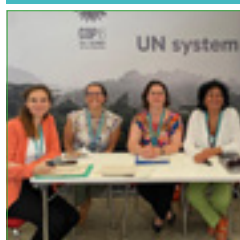

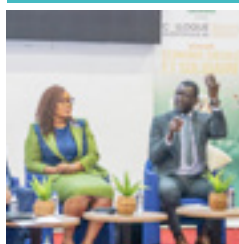
Political sessions, training workshops, a pitch competition, and the signing of a structuring agreement between GSEF and ARDCI shaped these three days.

## Scientific Symposium on the Social and Solidarity Economy in Africa

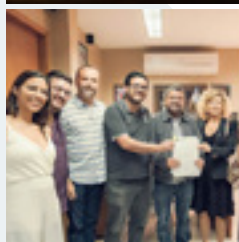
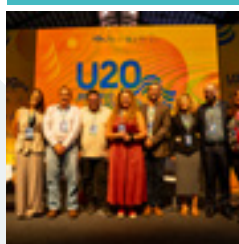
## GSEF Mission in Korea: Partner Mobilization and Youth Engagement

The GSEF carried out a strategic mission in South Korea, marked by strong mobilization during the National SSE Congress. ## The GSEF in Brazil: New Prospects for Cooperation around SSE

The GSEF conducted a ten-day mission to Brazil, centered around institutional meetings in Maricá, Rio de Janeiro, and São Paulo. In Maricá, the signing of a letter of intent with the municipality marked a key milestone in the city's upcoming membership in GSEF. Meaningful exchanges with CODEMAR and Banco Mumbuca provided insights into local initiatives in complementary local currency, urban agriculture, food security, and circular economy.

In Rio, as part of the Urban 20 summit held ahead of the G20, GSEF gave voice to SSE by co-organizing an official session dedicated to local SSE policies. This session brought together Brazilian institutional stakeholders, researchers, and cooperative representatives to showcase SSE solutions to face social and environmental challenges.

In São Paulo, meetings with the Paul Singer Institute, UNISOL, and the metalworkers' union opened new avenues for cooperation, particularly in preparation for the National SSE Forum in Brazil scheduled for 2025.

The momentum driven by the city of Maricá and the support expressed by several Brazilian networks offer promising prospects for a potential bid to host the GSEF Global Forum in 2027.

## ENVIRONMENTAL CHARTER & SSE PARTNERS

GSEF is aware of the environmental impact of the international travel inherent in the activities of a global organization, and strives to limit it. Remote communications and meetings are preferred. The train is systematically used when distances allow, and carbon offsetting is implemented for air travel. Rather than traveling directly, the GSEF secretariat calls on its continental co-presidents to take part in events in their region.

The secretariat is committed to a policy of responsible purchasing, calling on SSE players in the fields of accounting (Finacoop), banking (Crédit Coopératif), payroll (Assistea RH - cooperative), human resources (Agec & co), information system (association La Traversée) and communications (Otempora cooperative).





## FINANCIAL OVERVIEW AND OUTLOOKS

In 2024, the GSEF carried out its activities thanks to membership fees, public subsidies from the City of Bordeaux, Bordeaux Métropole, the Department of Gironde and the Nouvelle-Aquitaine Region, and through the one-off valorisation of its participation in specific events. Actual expenditures reached €380,306, while revenues amounted to €368,945.

The year also marked the launch of the 2024 membership fee campaign in April, supported by the development of a CRM (Customer Relationship Management) tool. After two years of manual processes, this GDPR-compliant interactive database now enables structured and semi-automated relationship management with members. Developed in partnership with the association Traversées, which supports GSEF in its digital environment strategy, the tool simplifies fee tracking, supports the production of digital resources, and improves membership database management. The Secretariat team received training to ensure its effective adoption and use.

GSEF warmly thanks its members and the four public authorities for their commitment, which helps cover the network's operating costs. This essential support also highlights the need to strengthen and diversify funding sources.

In this spirit of consolidation and sustainability, GSEF continues its efforts to diversify its financial base by responding to project calls and developing a structured service offer. This work led to the creation of a dedicated document showcasing the network's internal expertise and its ability to mobilize diverse international competencies.

## COMMUNICATION

In 2024, the GSEF continued its efforts to strengthen the network's identity and foster a sense of belonging among its members, while consolidating its external visibility. A set of communication tools was developed for members — including email signatures, logos, badges, and a representation protocol — to ensure consistent and shared messaging by the network's representatives.



**The GSEF newsletter** was relaunched after a two-year pause, with two publication campaigns. It is intended to become a regular tool for both internal and external communication, highlighting member initiatives, local dynamics, and the public policies they promote.



Two major campaigns shaped the year: one focused on **promoting the DakarGSEF2023 Forum proceedings**, and the other marking **the anniversary of the United Nations resolution on SSE**. Alongside these highlights, the GSEF maintained an active daily presence on social media, sharing Secretariat updates and showcasing member-led activities throughout the year.



In parallel, the GSEF actively contributed to communications related to the **BordeauxGSEF2025 Global Forum**, notably through its participation in the dedicated working group and the amplification of messages from co-organizers. The organization also supported the promotion of **the official launch event held in December 2024**, marking the start of the collective mobilization.
